## ELECTRA SONORA, MEXICO



### TECOLOTE CONCESSION

The Tecolote Concession is the 4,500 hectare northern component of the Electra Project and is located north of the Buenavista Concession at BCN/REM's Sonora Project. A Q3 exploration program identified two target areas interpreted to be underlain by sedimentary sequence favorable for lithium mineralization.

### TULE CONCESSION

The Tule Concession represents the southern portion of the Electra Project and comprises 18,125 hectares approximately 15 km by 12 km. Reconnaissance sampling from two sites of clay mineralization in banded sediments returned 347, 353, and 880 ppm Li from the northern cluster, and 950 and 1,000 ppm Li from the southern cluster (about 1.7 kilometers to the south east).

### AGUA FRIA CONCESSION

The Aqua Fria Concession was acquired due to exploration on the Tule Concession resulting in the discovery of a lithium-rich clay mineralization tracing along strike for approximately 4.5 km with maximum widths up to 800 m. Results from 35 additional samples yielded values ranging from 235 to 1,190 ppm Li and averaging 625 ppm Li, with three assay values over 1,000 ppm. The high lithium concentrations display a sequence similar to that found on the nearby La Ventana property held by Bacanora and REM.

### 2Mt @ 1.09 Li<sub>2</sub>O HISTORICAL RESOURCE ESTIMATE

**Initial sampling returned multiple samples running greater than 2% Li<sub>2</sub>O and as high as 2.86% Li<sub>2</sub>O.**

The Jackpot Lithium property, located in the Georgia Lake Area about 140 km NNE of Thunder Bay, Ontario, is close to the TransCanada Highway and the main railroad. The property has a historical resource on the Dyke No. 2 pegmatite zone, reported as 2Mt @ 1.09 Li<sub>2</sub>O estimated in 1956 by Ontario Lithium Company Limited\*.

### LI VALUES UP TO 1.33 WT. % LI<sub>2</sub>O FROM PRELIMINARY CHANNEL SAMPLING

The La Corne 2 lithium property is situated in the Preissac-Lacorne area, Abitibi, Quebec, adjacent and on strike with the Chinese-based Jilin Jien Nickel Industry Co. Quebec lithium. In Sept 2016 Alix announced lithium values up to 1.33 wt. % Li<sub>2</sub>O from its preliminary channel sampling of newly discovered spodumene-bearing granitic pegmatites dikes exposed in the southern part of the property.
